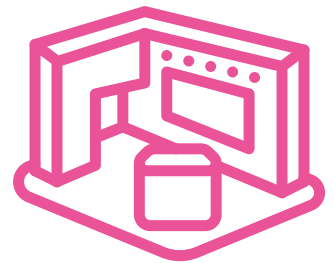

CONDITIONS OF PARTICIPATION

The participation conditions of SILICON ALPS Cluster GmbH (hereinafter referred to as SAC) apply to all legal relationships between SAC and the booking company (hereinafter referred to as Co.), which involve mutual business transactions within the meaning of the Austrian Commercial Code (UGB). Any deviations from these participation conditions are valid only if confirmed in writing by SAC.

Registrations are processed based on the availability of remaining space and are ordered according to the time of receipt at SAC. The number of participants is limited. The decisive factor is the date and time of the email, fax, or receipt stamp of the registration form.

The Co. is bound by its booking from the receipt of the registration form at SAC until October 2, 2024, inclusive. If the booking is withdrawn by the Co., it is obliged to fulfill the cancellation conditions of SAC (registration form, page 3).

If a registration cannot be considered due to the limited number of participants, the respective Co. will be informed by SAC. From the time of notification of this non-consideration by SAC, the Co. is no longer bound by its booking.

The receipt of the registration form at SAC does not constitute a contract. The contract is only valid upon written confirmation of the registration form acknowledging these participation conditions by SAC (acceptance of the booking).

The amount payable by the Co. is due for payment within 14 days after receipt of the invoice issued by SAC. SAC reserves the right to withdraw from the contract for any reason. Withdrawal from the contract does not trigger any warranty or compensation claims. Any transfer of rights from this contract to third parties, particularly the transfer of exhibition spaces, is not permitted without the consent of SAC.

SAC is entitled to restrict or change the provided exhibition space to the necessary extent according to the grid measure of the trade fair management due to technical or design-related circumstances and the overall appearance of the exhibition stand.

Reorders and changes by the Co. will be charged. Services ordered in Austria but not accepted or canceled on-site by the Co.'s stand staff will also be charged.

SAC is responsible for the overall appearance of the exhibition stand. To ensure a uniform overall appearance, the use of the company's own stand construction materials, such as roll-ups and posters, as well as the commissioning of own stand construction companies by the Co., is not permitted. The decision on the number and space of roll-ups for the Gold and Silver packages is at the discretion of SAC. The Co. is responsible for the packaging and transport of the exhibition goods, as well as for the removal of the exhibition goods and disposal of the packaging after the trade fair.

All costs for insurance of the exhibition goods, which are required by the trade fair operator, are to be borne by the respective insured party.

For playing copyrighted music, protected audiovisual presentations, etc. at the exhibition stand, the Co. must provide SAC with written permission from the copyright holders or the respective collecting societies (e.g., AKM) or directly pay any fees that may arise.

SAC assumes no liability for publications, performances, presentations, exhibits, advertising, marketing, information, consulting, etc., or any other activities or appearances of the Co., and the Co. undertakes to indemnify and hold SAC harmless against legal violations and liability claims from third parties.

SAC assumes no liability for any items provided or handed over by the Co. SAC's liability for damages of any kind due to slight negligence is expressly excluded.

Austrian law applies exclusively. The Co. Sales Law is expressly excluded. For any disputes arising from this legal relationship, including those concerning the existence or non-existence of this legal relationship, the competent court in Graz, Austria, is agreed upon.

All contractual agreements, including side agreements, require written form to be valid. If individual provisions of this contract are invalid, the validity of the remaining provisions is not affected. The invalid provision is to be replaced by a valid one that comes close to the intended goal.
