Terms and Conditions of Participation

General Terms and Conditions (GTC)

Valid from January 1, 2026

1. Organizer

The organizer is

2. Registration

Registration for participation takes place via the online tool provided for the respective event (e.g., Pretix). The booking must be completed in full. Upon completion of the booking, the participant confirms that they have read and agreed to the applicable General Terms and Conditions of Participation by actively clicking to accept them. The General Terms and Conditions of Participation apply once the booking has been completed. When registering, it is assumed that participants will correctly select the participation category that applies to them (e.g., member/non-member). However, Silicon Saxony Management GmbH will subsequently check the information provided and reserves the right to correct and adjust the selected category accordingly when invoicing.

Registration is possible until the registration deadline specified in the registration form, depending on ticket availability. The organizer is responsible for extending the registration deadline if capacity has not yet been reached. Registration is considered an irrevocable and binding contractual relationship between both parties within the scope of the cancellation options.

Silicon Saxony Management GmbH will confirm your registration for the respective event via email.

3. Terms of payment

After registration, you will receive an invoice, which is due 14 days after receipt. Payments can be made by credit card or bank transfer.

4. Provision of services and right of withdrawal

We reserve the right to make changes to the content or timing of the event program and to the speakers. We are entitled to withdraw from the contract if it is not possible to hold the event economically due to an insufficient number of exhibitors, sponsors, or participants. This also applies to reasons other than those mentioned in 4.a that are not within the organizer's area of responsibility. In this case, we will inform all participants immediately. All payments already made will be refunded immediately. Further claims by visitors are excluded, unless the organizer is guilty of intent or gross negligence.



4.a If, at the time of the event, restrictions imposed by the federal or state government make it impossible to hold the event, the contract shall be subject to the condition subsequent that the event would be prohibited one month before its contractually agreed start date due to government measures, such as pandemics.

The decisive factor is the prohibition of any events on the above-mentioned date; it is irrelevant whether the event can be held on the agreed date [example: the condition subsequent occurs if an event planned for October 1, 2020, cannot take place due to a general ruling on September 1, 2020].

In the event of termination of the contract due to the occurrence of the above condition, Silicon Saxony Management GmbH shall receive 15% of the agreed remuneration as a processing fee.

5. Cancellation and change of booking

- a. You may cancel your registration free of charge up to 28 days before the start of the event without giving a reason. Cancellations must be made in writing to the organizer. If cancellation is made up to 7 days before the start of the event, 50% of the participation fee will be charged as a cancellation fee. In the event of later cancellation or non-participation, 100% of the participation fee will be due. Alternatively, a replacement participant may be named at any time free of charge. Any refunds will be made after the event.
- b. For no-shows despite binding registration for free events, we charge a **no-show fee of €69**. This does not apply to virtual events and working group events. Cancellation of your registration is only possible for free events up to 24 hours before they begin.

6. Image and sound recordings

The Silicon Saxony Management GmbH is entitled to have photographs, drawings, film and video recordings made of the event and to use them for advertising or press publications. If the participant does not agree to this, they have the option of expressing their disagreement in advance of the event. This also applies to press or television recordings with the consent of Silicon Saxony Management GmbH.

Press conferences or audio recordings at the event that are initiated by participants themselves must be notified to Silicon Saxony Management GmbH in advance.

7. Note on data protection

Participant data (e.g., company name, address, first and last name, title, email address) will be processed for the purpose of conducting the event, managing participation, and for customer care and information on the basis of Art. 6 (1) lit. b and lit. f DSGVO.

A list of participants may be created for each event, which may contain the following information: company name, company headquarters (city, country), if applicable, title, and first and last name of the participants.

Such a list will only be passed on to other participants, sponsors, or exhibitors on the basis of express consent in accordance with Art. 6 (1) (a) DSGVO, which is obtained during the registration process.



Consent that has been given may be revoked at any time with effect for the future. Revocation is possible up to five days before the start of the event at the latest and must be made in writing to the organizer. The lawfulness of the processing carried out until revocation remains unaffected by this.

8. Applicable law / place of jurisdiction

The participation agreement, including these General Terms and Conditions, is subject to German law, with the exception of the UN Convention on Contracts for the International Sale of Goods. The place of jurisdiction for all claims and legal disputes is Dresden if the contractual partner is a merchant, a legal entity under public law, or a special fund under public law. In all other respects, the statutory provisions apply.
